#### Who we are?

Nipissing Serenity Hospice (NSH) is a bilingual, 10-bed residential palliative care facility. The NSH offers free services to residents of Nipissing and East Parry Sound districts, and welcomes patients regardless of age, religious beliefs or culture.

#### What we care about?

It is a place where spiritual, psychosocial and physical needs are met to relieve pain and suffering in the final stages of life. Professional staff and trained volunteers work alongside those who are living with life-challenging illnesses, supporting them and their caregivers through the difficult transition associated with grief & bereavement.

#### Why we need your help?

Although we are partially funded by the Provincial government for direct clinical care, we still need to raise close to \$700,000 annually to support our programs, operate our facility and enhance our residents' experience.

# FUNDRAISING

Here are some fundraising ideas that you can safely do during Covid-19

1

Online Party (Pampered Chef, Thirty-One, Tocara, etc.)

Who doesn't like to shop?! This is a great way to support local businesses or home party reps in your area. Ask the businesses to donate proceeds from sales or collect donations.



## CHARITABLE CONTRIBUTIONS and Tax Receipts

A charitable tax receipt is given to individuals or businesses who make a donation to a registered Canadian charity. Nipissing Serenity Hospice automatically receipts all eligible donations of \$20 or greater.

Sponsorships, admission fees, raffle tickets, item purchases and donations of services are not eligible for tax receipts. Some in-kind donations may be eligible to receive a receipt.

Tax receipts can only be processed by Nipissing Serenity Hospice once the funds are remitted with complete documentation. Processing tax receipts takes 2-4 weeks after the donation has been received.

To properly process a tax receipt we require the following information:

- 1. Donor's name
- 2. Donor's address (including postal code)
- 3. Email
- 4. Donor's telephone number
- 5. Amount of donation
- 6. The actual donation (cash, cheque or credit card)
